EXECUTIVE ORDER NO. 05 -1993

CREATION OF INVESTIGATION DIVISION WITHIN GOVERNOR'S OFFICE

It is inevitable that difficult problems and complaints have been filed with the office of the Governor. More will be filed from time to time. Some of these complaints are directed to certain governmental departments, others are directed to certain governmental departments, others are directed to personnel of the government. Some of the complaints have merits. Others are questionable. The Governor and Lt. Governor should nevertheless look into these complaints and determine their validity. Appropriate actions should be taken whenever necessary in order to serve the public demands of maintaining order in society.

Section |: Authority:

This Executive Order is issued under the authority granted in Article IV, Section 5, American Samoa Revised Constitution and Title 4, Chapter 01, Section .0111(b), American Samoa Code Annotated.

Section II. Purpose;

This Executive Order mandates the establishment of an Investigation Division in the Governor's Office to investigate complaints and cases that have been filed with the Governor's Office.

Section III. Establishment of Investigation Division:

It is hereby established an INVESTIGATION DIVISION within the Governor's Office, to be manned by three personnel or more according to the work load. This Dividion shall be responsible to the Governor directly.

Section IV. Duties and Functions of Division:

The Investigation Division shall investigate all cases assigned to them by the Governor or Lt. Governor and to perform all other responsibilities assigned to them by the Governor or Lt. Governor or their designee. All reports made by the Division shall be submitted to the Governor or Lt. Governor or their designee.

Section V: Employees:

The Division shall consist of three personnel, one of whom is designated the head of the Division. The other two are designated as Investigators. Other employees may be added according to the work load of the Division.

Section VI: Salary and Grade;

Salary and grade shall be set by the Governor after consultation with the Director of the Department of Human Resources.

Section VII: Employment Status:

Employees of the Division are considered Political Appointees and are not Career Service employees. They serve at the pleasure of the Governor and may be terminated by the Governor according to his pleasure with or without cause.

Section VIII: Overtime and Compensatory Time:

Employees of the Division are not entitled to overtime nor compensatory time. Furthermore, employees are not entitled to increments.

Section IX: Effective Date:

This Executive Order is effective immediately ___May 7th____, 1993.
