EXECUTIVE ORDER NO. 6 -1987

ESTABLISHMENT OF THE ASG
VEHICLE POLICIES AND PROCEDURES
COMMITTEE; REORGANIZATION OF THE MOTOR POOL

By the authority vested in the Governor of American Samoa by the Revised Constitution and laws of American Samoa, it is hereby ordered as follows:

1. Establishment of the ASG Vehicle Policies and Procedures Committee

There is established within the executive branch of the American Samoa Government the ASG Vehicle Policies and Procedures Committee. The Committee shall consist of four members appointed by the Governor. Terms of office shall be indefinite. The Governor shall designate the Chairperson.

- 2. Committee Functions.
- (a) The Committee shall:
- (1) immediately carry out its specific powers and duties prescribed in General Memorandum No. 44-1987 pertaining to the unauthorized use of government vehicles and assist in the full implementation of this General Memorandum; and
- (2) develop policies and procedures for the acquisition, use, maintenance and disposal of government motor vehicles in the near-, mid-, and long terms.
- (b) The policies and procedures proposed by the Committee shall specifically address the future role of the Government's Motor Pool, including but not limited to authority, manpower, and budget requirements.
- (c) The Committee shall recommend those policies and procedures it considers appropriate for adoption as rules having the force and effect of law under the Administrative Procedure Act, 4.1001 ASCA et seq.

3. Reorganization of the Motor Pool.

Until further notice, the Motor Pool of the government is transferred to the Office of the Governor to be under the Governor's immediate direction and supervision.

4. Cooperation of Other Agencies.

- (a) All government departments, offices, and other agencies are directed to fully cooperate in the implementation of this Executive Order and General Memorandums Nos. 44-1987 and 45-1987.
- (b) The Department of Public Safety, in particular, shall provide the necessary assistance to the ASG Policies and Procedures Committee to implement the policies and procedures prescribed by General Memorandum No. 44-1987 and adopted pursuant to this Executive Order.

Rescission.

General Memorandum No. 11-1985 establishing the Vehicle Use Screening Committee and all other prior executive orders and general memoranda dealing with the use of government motor vehicles are rescinded in their entirety.

6. Effective Date.

This Executive Order is effective immediately.
