AN ORDER DIRECTING REDUCTION OF WORKING HOURS

Section 1: Authority

This Executive Order is issued under the authority granted to the Governor in Article IV, Section 6 and Section 7, American Samoa Revised Constitution and Title 4 A.S.C.A. Section 4.0111(b).

Section 2: Preamble and Purpose

The continuing deterioration of the American Samoa Government's (ASG's) financial condition compels me to reduce the work week for ASG employees from 40 to 30 hours per week. This action is most unpleasant for me, but it is required in order to avoid even more drastic measures and, hopefully, will only be a temporary necessity.

Section 3: Implementation

(a) Effective March 9, 1998, all employees, including employees of the American Samoa Community College, will be required to take twenty (20) hours off every two weeks. Each department, agency and office shall prepare a schedule reflecting the hours each employee is to work and the hours the employee is to take off. Directors and office and agency heads are to arrange such schedules in such a manner as to avoid disruption of the functions of their respective departments and to ensure that their offices remain open eight (8) hours per day, five (5) days per week. Should the office be required to operate outside of normal working hours, the schedules shall be arranged in such a manner as to allow the department to continue to function, meet its responsibilities and avoid disruption of services to the public.

(b) This order does not apply to two-year contract employees, doctors, nurses, laboratory technicians, x-ray technicians, nor to employees of the American Samoa Power Authority.

Section 4: Effective Date

This order is effective March 9, 1998 and will remain in effect until further order.
