AN ACT APPROPRIATING THE SUM OF \$75,000.00 FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790, FOR AN INITIAL PAYMENT TO PARTIALLY FUND THE SETTLEMENT AGREEMENT ENTERED INTO AS A RESOLUTION OF LITIGATION ENTITLED UIAGALELEI IONA V. AMERICAN SAMOA GOVERNMENT, IN HIGH COURT CIVIL ACTION NO. 22-2000.”


BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$75,000.00 from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790, for the purpose of an initial installment payment to partially fund the Settlement Agreement entered into as a resolution of litigation entitled Uiagalelei Iona v. American Samoa Government, in High Court Civil Action No. 22-2000.

Sec 2. Source of funding.

Funds of \$75,000.00 shall be payable from budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790.




