AN ACT ADDING THE UNITED STATES GOVERNMENT AS A JURISDICTION TO WHICH INDIVIDUALS CHARGED WITH CRIMES MAY BE EXTRADITED; AMENDING SECTION 46.0904 ASCA.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:


Section 1. 46.0904 is amended to read:

"46.0904 Duty of Governor to arrest persons charged with crimes in other states.

Subject to the qualifications of this chapter and the provisions of the Constitution of the United States controlling and acts of Congress in pursuance thereof, it is the duty of the Governor of this Territory to have arrested and delivered up to the United States Government authorities or to the executive authority of any other state of the United States any person charged in that state or by the United States Government with treason, felony or other crime, who has fled from justice and is found in the Territory."
