AN ACT APPROPRIATING THE SUM OF \$55,000 FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790 FOR THE PAYMENT OF A SETTLEMENT ENTERED INTO BETWEEN THE GOVERNMENT AND THE ADMINISTRATOR OF THE ESTATE OF TANUGAMANONO PELETI IN HIGH COURT CIVIL ACTION 201-94.

Section 1. Appropriation.






