As the only U.S. Territory south of the equator, American Samoa is an exciting place to practice law that will serve as an exceptional foundation to an empowering and satisfying legal career or an enriching addition to a storied legal career. A wide range of opportunities abound not only in public service but in the private sector as well.

As an Assistant Attorney General or an Assistant Public Defender, you will gain valuable litigation experience in a short amount of time. Positions are also available as a Judicial Law Clerk in the High Court of American Samoa as well as the Office of the Legal Counsel to the Governor where novel legal issues are more a rule than an exception. Expansion at the Office of the Administrative Law Judge and establishment of the Office of the Secretary of American Samoa sees a further need for exceptional legal talent.

In the private sector, business is booming and is so robust that private practitioners are turning away clients.

So, no matter where you go, be it with the government sector or the private sector, you will play an important role right at the outset.

WHAT TO EXPECT

Moving to a tropical island in the middle of the Pacific is not for the faint of heart and candidates with an adventurous spirit are encouraged to apply. A very traditional way of life is the norm but with a touch of Americana.

Local hiking trails are bountiful with stunningly beautiful scenery throughout and water recreation activities abound. Spend an evening at the world famous "Tisa's Barefoot Bar" after a hard day's work with cold brews and a traditional "umu." Charter a day trip on board the "MV Deep Calling" for game fishing or scuba dive at the "Fagatele Bay National Marine Sanctuary." A quick flight East to experience and explore the lush and unspoiled beauty of the Manu'a islands with its sparkling white beaches, crystal clear waters, and warm, welcoming locals is a highly rewarding adventure.

A short flight West to Samoa and swim the pristine waters of "Palolo Deep National Marine Reserve" or relax at the "Saletoga Beach Bungalows & Hotel" within the hour. Or from there, you can visit other exotic locations such as Fiji, New Zealand, and Australia.

In American Samoa, you will have a well-balanced and challenging career with the opportunity to make an impact almost immediately while having easy access to a wide range of local outdoor activities, immersion in an ancient yet thriving culture, and exotic vacationing opportunities that are a hop, skip and a jump away.

High Court of American Samoa

As an "unincorporated" territory, not all provisions of the U.S. Constitution apply which makes the practice of law in American Samoa quite unique. Geographically speaking, the closest U.S. District Court is in Hawaii, however, the U.S. District Court in Washington D.C. also has jurisdiction by virtue of the fact that American Samoa is administered by the U.S. Department of Interior. The High Court of American Samoa is the sole court in American Samoa consisting of a Chief Justice and an Associate Justice, both of whom are appointed by the United States Secretary of Interior.





The High Court consists of four distinct divisions, The Trial Division, the Lands & Titles Division, the Appellate Division, and the Family Drug & Alcohol Division. The rest of the judiciary consists of a local District Court, and village courts. Although not technically a federal court, it exercises limited jurisdiction over traditionally federal matters such as admiralty/maritime matters. The High Court building is listed on the National Register of Historic Places and was built in 1900. It is a picturesque building that maintains its original and distinct Southern Plantation style and has withstood two World Wars, a multitude of hurricanes, thousands of inches of torrential rainfall and a devastating Tsunami.








American Samoa is a well balanced blend of traditional living with a heavy influence of American music, food, and traditions. Located some 2500 miles from Honolulu, Hawaii, it is a group of six islands and is the only U.S. territory in the southern hemisphere. Tutuila is the main island and is the central hub of the island group.

With a culture stretching back 3000 years, the Samoan culture is a communal way of life and is actively "lived" throughout the islands. The sense of community is quite prominent and people are welcoming and sociable. Do not be surprised if you are invited to join a local family for a barbeque, a game of volleyball, a few cold ones, or even dinner. Small wonder that famous Scottish writer Robert Louis Stevenson spent the last few years of his life amongst the Samoan people.



Although very traditional, most locals are bilingual, speaking fluent Samoan and English with a prominent influence of American food, music, and traditions. American sports, particularly the National Football League and the National Basketball Association, are extremely popular on island but international rugby and soccer is quickly gaining in popularity as well.

Additionally, only certain parts of the U.S. Constitution are applicable here. American Samoa is a great place to work if you enjoy the outdoors. If you are adventurous, or like hiking, snorkeling, fishing, or surfing, all of those opportunities are available if you look hard enough and have the right attitude. Also, if you have a family, you will appreciate the work-life balance that working in American Samoa provides. This is a very family friendly place.

American Samoa has presented me with an unparalleled opportunity to practice law. I have worked in novel areas of the law that I never would have considered before coming here. My family and I came to American Samoa to experience something different than life in the suburbs. We have not regretted it. I was hired as a prosecutor. I enjoyed the challenges of working in a fast-paced environment and gained experience with bench and jury trials. There are challenges. Many of the victims and defendants have limited English proficiency. Jury trials are all bilingual, and I had to adapt my arguments to accommodate translation. It made my arguments more pointed and effective. The Attorney General's Office is relatively small, and I took the opportunity to switch to the civil division. There I worked as the general counsel for a variety of agencies, including the Department of Health. I worked with the medical professionals here and in other Pacific island nations. I discovered a passion for it just as the world entered the COVID pandemic. When the Lemanu administration came into office, I was asked to join as the Chief Legal Counsel. The work in the governor's office continually presents new issues in areas of the law that are novel. The nature of American Samoa creates a unique legal environment. The territory is the size of a small county, so the American Samoa Government carries out all of the functions that one would normally expect of a state and local government in addition to maintaining its own customs and immigration laws. Few places will give an attorney more responsibility early on and the opportunity to explore multiple areas of the law.

Minimum Qualifications & Compensation Package

MINIMUM QUALIFICATIONS REQUIRED

- A Juris Doctor Degree from an ABA accredited law school
- Member in good standing of any US State or Territory
- Must have excellent legal writing and advocacy skills. A writing sample will be required upon application
- Experience demonstrating the ability to make analytical and reasoned judgments on issues of public sensibility
- Ability to develop a team approach to problem solving
- Must be able to provide three professional recommendations from licensed attorneys

COMPENSATION PACKAGE FOR EXECUTIVE BRANCH ONLY

Starting pay:

- \$65,000 annually for attorneys with less than three years of experience
- \$75,000 annually for attorneys with three or more years of experience
- \$80,000 annually for supervisory level attorney's
- \$85,000 annually for Deputy Attorney General and the Public Defender

Benefits

- Government provided housing or \$1000 per month housing allowance
- Eligible for Federal Public Service Loan Forgiveness program
- Health Insurance
- Salary step increase annually
- Utility allowance of \$500 per month
- Eligible for John R. Justice Formula Grant funds for repayment of student loans
