AN ACT APPROPRIATING THE SUM OF \$1,100,000 TO FUND THE OPERATIONS  
OF THE LEGISLATURE OF AMERICAN SAMOA FOR THE REMAINDER OF  
FISCAL YEAR 2013.”

Preamble:

WHEREAS, the original budget for the Legislature of American Samoa for Fiscal Year 2013 was \$6,200,000; and

WHEREAS, by previous Supplemental Appropriation an additional \$500,000 was added to the Fiscal Year 2013 budget; and

WHEREAS, it is now projected that the Legislature will overrun its current budget of \$6,700,000 by an additional \$1,100,000; and

WHEREAS, the Legislature of American Samoa is a vital and co-equal branch of the American Samoa Government, and its continuing operations are critical to the orderly functioning of the lawmaking process and its legislative oversight role; and

WHEREAS, there are presently a number of bills before the Legislature, nominations of Directors and members of Boards and Commissions, and the Fiscal Year 2014 Proposed Budget, requiring the Legislature’s timely attention.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA

**Section 1. Appropriation of revenue.**

There is appropriated the sum of \$1,100,000 to provide funding for the Legislature of American Samoa for the remainder of Fiscal Year 2013 in the following object classes:






