

THE THIRTY-THIRD LEGISLATURE OF AMERICAN SAMOA

First Regular Session

Begun and held at Fagatogo, Tutuila, American Samoa
on Monday, the fourteenth day of January
two thousand and thirteen

AN ACT APPROPRIATING THE SUM OF \$5,000,000 TO PROVIDE FUNDING FOR THE PARTIAL OR COMPLETE SETTLEMENT OF VARIOUS LEGAL CLAIMS AGAINST THE AMERICAN SAMOA GOVERNMENT, FUNDING TO REIMBURSE DISALLOWED GRANT DRAW DOWNS, FUNDING FOR UNFUNDED EXPENDITURES BY THE OUTGOING ADMINISTRATION, AND FUNDING FOR OTHER MISCELLANEOUS EXPENDITURES.

Preamble:

Due to the urgent need to provide funding to settle claims brought by the United States Department of Labor for violations of the Fair Labor Standards Act and the Equal Employment Opportunity Act, and to settle judgments entered against the American Samoa Government by the High Court of American Samoa, and to reimburse disallowed grant draw downs, and to fund unfunded expenditures by the outgoing administration, and to fund other miscellaneous activities, this act shall be effective immediately upon passage by the Legislature and approval by the Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$5,000,000 to provide funding for the following necessary expenditures and continuing activities of the government:


Sec 2. Source of funding.

Funds in the amount of \$5,000,000 shall be made available from unbudgeted, unexpended and unobligated revenues of the American Samoa Government for fiscal year two thousand and thirteen from the following sources:



Sec 3. Effective date.




