AN ACT ALLOWING CUSTOMS AGENTS TO SEARCH AND INSPECT ANY AND ALL VESSELS, AIRCRAFTS, AND PERSONS ENTERING OR LEAVING THE TERRITORY INCLUDING THE USE OF X-RAY SCANNERS TO INSPECT ALL CONTAINERS, LOOSE CARGO, PARCELS, AND MERCHANDISE; AMENDING SECTIONS 27.1003 AND 27.1018 A.S.C.A.

Preamble:

WHEREAS, it is a vital duty of the Department of Treasury Customs Divisions to search and inspect incoming and outgoing persons and items from the territory; and

WHEREAS, the Department of Treasury will be purchasing new state of the art x-ray scanners to assist Customs in more efficiently inspecting incoming containers, cargo, parcels, vehicles, and merchandise; and

WHEREAS, it is likely that most illegal drugs and weapons on island are transported into the territory by person or parcel, and that general excise taxes are under-collected as a result of the inefficient practices now being utilized; and

WHEREAS, this technology will greatly aid customs officers in detecting illegal and taxable items being transported into and out of the territory; and

WHEREAS, most ports in the United States have similar x-ray technology in use.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. 27.1003 is amended to read:

"27.1003 Inspection of persons and incoming merchandise and baggage.

(a) All persons entering or leaving American Samoa may be searched by a customs officer. All merchandise and baggage imported or brought into American Samoa from any foreign country shall be unloaded in the presence of, and inspected by, a customs officer, and that officer may require the

owner or his agent or other person having charge or possession of any trunk, traveling bag, sack, valise or other container, or any closed vehicle, to open it for inspection.

(b) The customs officer may inspect without warrant any person departing or arriving on any island in the Territory to determine whether such person is violating the laws and regulations pertaining to entry into American Samoa of individuals, vessels and goods. A strip search may be performed if there is real or reasonable suspicion supported by the objective and articulable facts that the passenger is concealing evidence of a crime or contraband upon his or her person.

(c) Whenever a vessel, aircraft or any other form of transportation from a foreign port or place, or from a port or place within the Territory, arrives or exits an American Samoa port of entry, the appropriate customs and border security officer is authorized to enforce, inspect, search, and ensure compliance with all customs regulation including collection of appropriate excise taxes. This includes the search of the persons, baggage, and merchandise discharged or un-laden from such vessel, whether or not any or all such persons, baggage, or merchandise has previously been inspected, examined, or searched by customs officers.

(e) (d) Security area:

(1) Any person who voluntarily enters a security area at the airport or seaport is subject to customs inspection as provided for in this section.

(2) Prospective passengers who enter a security area at the airport or seaport and later decide not to travel are required to return through customs inspection and clearance in the same manner as an arriving passenger on international travel.

(d)(e) Without a search warrant but upon reasonable cause to suspect that the mail contains dutiable or prohibited items, designated customs officers of American Samoa may open or inspect the contents of mail in the customs inspection of mail which has originated outside the customs territory of American Samoa and is addressed for delivery inside American Samoa.

(e)(f) The inspections may be conducted only in accordance with part 820, USPS Publication 42, International Mail, relating to cooperation with the U.S. Customs Service on inspection of imports applicable federal statutes and regulations.

(f)(g) Unless any of the following actions are authorized by a search warrant issued under Rule 41 of the High Court Rules of Criminal Procedure, customs personnel shall not read, allow any other person to read, divulge, or transfer to any other person any correspondence contained in sealed mail; or divulge, read, allow any other person to read, or listen to any paper or recording which is correspondence for the blind contained in unsealed mail; or divulge, read, allow any other person to read, or transfer to any other person correspondence of school children in unsealed mail.

~~(g)(h) Customs personnel shall not, without a search warrant, open, inspect, read, or seize any mail in postal custody which has not originated outside American Samoa or which has diplomatic or consular immunity from customs inspection (USPS Publication 42, International Mail, sections 821.la and 821.lb.) according to federal law and regulations.~~

~~(i) To execute the customs responsibilities that include searching for contraband, weapons and other illegal or undeclared merchandise, custom and border security officers may employ the use of scanners or x-ray equipment for inspecting all containers, loose cargo and merchandise, and parcels. The importer, exporter, and/or owner of the examined merchandise is responsible for the cost of this inspection, examination and search. The cost shall be paid upon completion of the scanning."~~

Sec 2. 27.1018 is amended to read:

"27.1018 Customs officers service fees.

(a) Charges shall be collected for services of customs officers from the owner, master or agency of a vessel as follows:

(1) attendance of customs officers at any place other than port of entry, per day, \$30.00;

(2) attendance of customs officers outside of regular business hours, per hour, \$15.00;

(3) granting clearance to commercial vessels per entry and per departure, \$6.00;

(4) granting clearance to noncommercial vessels, per entry and per departure, \$50.00.

(5) processing Customs Declaration of Entry forms, \$5.00 per declaration per vessel. This charge shall not apply to passengers. The revenues from this charge shall be deposited in an account earmarked for and dedicated to the American Samoa Economic Development Authority for the repayment of its Series 2015 Bonds. Upon full repayment of said bonds, collection of this charge shall be deposited in the general fund and shall be available for appropriation by the Legislature.

(b) The schedule of charges in paragraph (a) (1) and (a)(2) contemplates that those charges are calculated per man/per hour, or per man/per day, provided that where attendance of customs officers as paragraph (a)(1) is off Tutuila Island, the cost of travel, per diem, or other costs, including overtime, will be charged and collected from whomsoever requires such off-island attendance of customs officers.

(c) X-Ray Scanning fees as described in 27.1003 (i) are as follows:

(1) \$200 for a 40 feet or more container;

(2) \$200 for less than a 40 foot container (including all 20 foot containers);

(3) \$50 for loose cargo pallet;

- (4) \$50 per vehicle or heavy equipment;**
(5) \$10 per parcel imported for commercial purposes; and
(6) other scanning fees as determined by customs and enacted by administrative rulemaking."

Sec 3. Effective date.

In accordance with Article II, Section 19 of the Revised Constitution of American Samoa, this bill shall become effective 60 days after the end of the session at which it has been passed.


