**AN ACT CLARIFYING AND CORRECTING TITLE 25 ASCA DEALING WITH  
COMMUNICABLE DISEASES AND PROHIBITING THE DISCLOSURE OF IDENTITY  
OF PATIENTS WITH COMMUNICABLE DISEASES; AMENDING SECTION 25.0402  
ASCA; AND CREATING SECTION 24.0419 ASCA.**

**BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:**

Section 1. 25.0402 is amended to read:

"25.0402 Report of communicable diseases--Duty of medical personnel.


Any physician, dentist, medical or dental officers, or nurse of the department of health who has knowledge or suspected knowledge of the presence of any communicable disease or any other disease dangerous to the public health shall report the same to the ~~United States Public Health Service~~ and to the director within 48 hours after diagnosis unless a different time is prescribed by regulation, together with the name, age, and sex of the person affected, the village in which the person may be found, and such other information as may be required by regulation. When the patient is immediately hospitalized, the physician or medical officer in charge of the hospital care of the patient shall make the report. The director shall forthwith report such cases to the United States Public Health Services."

Sec 2. There is created a section 25.0419 which reads:

"25.0419 Confidentiality.

Records containing the identity of individuals pursuant to this chapter may under no circumstances be disclosed or transferred to any unauthorized person or public or private agency. Employees of the American Samoa Government who violate this section shall be subject to disciplinary action pursuant to Title 7, and Title 4 ASCA."
