
BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:


**Section 1. Appropriation of revenue.**

There is appropriated the sum of \$100,000.00, from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790, for the purpose of payment of the Settlement and Release Agreement entered into as a resolution of litigation entitled So'i Save v. Government of American Samoa, et. al., in High Court Civil Action No. 108-00.

**Sec 2. Source of funding.**

Funds of \$100,000.00 shall be payable from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790.




