

THE TWENTY-SEVENTH LEGISLATURE OF AMERICAN SAMOA

AN ACT PROVIDING THAT THE UNITED STATES INTERNAL REVENUE CODE IN EFFECT ON DECEMBER 31, 2000 SHALL BE APPLICABLE TO AMERICAN SAMOA; AMENDING SECTION 11.0403 A.S.C.A. AND PROVIDING FOR AN EARLY EFFECTIVE DATE.

Preamble:

Due to the urgent need to maintain the current tax rates and provisions of the United States Internal Revenue Code applicable to American Samoa, this act shall be effective upon passage by the Legislature and approval by the Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. 11.0403 is amended to read:

"11.0403 Imposition of tax--Citation.

(a) The income tax and the income tax rules in force in the United States of America ~~and those which may hereafter be enacted or adopted in effect on December 31, 2000~~, where not clearly inapplicable or incompatible with the intent of this section, are adopted by American Samoa, and shall be deemed to impose a separate territorial income tax, payable to the government. These laws include, but are not limited to, the following provisions of the United States Internal Revenue Code of 1954: subtitle A; chapters 24 and 25 of subtitle C, with reference to the collection of income tax

at source on wages; and all provisions of subtitle F which apply to the income tax, including provisions as to crimes, other offense and forfeitures contained in chapter 75.


(b) For reference purposes, this chapter and chapter 11.05, and all provisions of the United States Internal Revenue Code of 1954 adopted by reference in subsection (e), may be cited as the "Samoan Income Tax Act."

Sec 2. Effective date.

Due to the urgent need to maintain the current tax rates and provisions of the United States Internal Revenue Code applicable to American Samoa, this act shall become effective when passed by the Legislature and approval by the Governor.


