AMENDING SECTION 22.0808 A.S.C.A.


BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:


Section 1. 22.0808 is amended to read:


"22.0808 Summons-Service.

(a) The summons may be served by the delivery of a copy thereof to the defendant, or by affixing a copy thereof to the ~~steering wheel of the vehicle~~ outside of the vehicle's front windshield, if the vehicle is unoccupied.

(b) The summons may be served by any member of the Department of Public Safety, a police officer or any deputy."


