AN ACT ALLOWING POLICE OFFICERS TO TICKET DRIVERS OR THE REGISTERED OWNER OF VEHICLES UNLAWFULLY PARKED IN DISABLED PARKING STALLS; AUTHORIZING THE OFFICE OF PROTECTION AND ADVOCACY TO ISSUE TICKETS AND IMPOSING NEW PENALTIES; AMENDING SECTIONS 22.0321 AND 22.0807 A.S.C.A.

Preamble:

WHEREAS, parking stalls designated for disabled individuals is required by law and a crucial benefit to facilitate access to public spaces; and

WHEREAS, the Office of Protection and Advocacy for the Disabled recently promulgated new rules to ensure disabled parking stalls are uniform and regulated; and

WHEREAS, at times it is difficult to readily find drivers who unlawfully park in disabled parking stalls, this amendment will allow police officers the ability to ticket the registered owner of the vehicle to deter this activity; and

WHEREAS, enforcement is lacking because of weak and unclear statutes and lacking manpower.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. 22.0321 is amended to read:

"22.0321 Stopping or parking near fire station or hydrant--Parking for disabled persons.

(a) No person may stop or park any vehicle, or leave it standing, in front of a fire station or within 15 feet of a fire hydrant except when such vehicle is attended by a licensed operator or chauffeur who is seated in the front seat and who can immediately move such vehicle in case of necessity.

(b) No person may park a vehicle in a space designated for vehicles of disabled persons unless the vehicle so parked exhibits on the said vehicle a disabled person's sticker properly issued by the Office of Protection and Advocacy, and at the time it is so parked was driven by or transporting such disabled person. ~~A person who violates this subsection shall be guilty of a Class C misdemeanor and shall be punished accordingly.~~

(1) Any police officer may issue a citation to the driver of the vehicle in violation of this statute or, if the driver is not readily available or identifiable, the registered owner of the vehicle.

(2) Pursuant to A.S.C.A. 22.0808, notice is satisfied by delivering a copy of the summons to the defendant or by affixing a copy thereof to the outside of the vehicle's front windshield if unoccupied.

(3) In addition to police officers, the Director of the Office of Protection and Advocacy may authorize his employees to issue citations to violators of this subsection, provided that any person so authorized has the training and experience necessary to perform the job as determined in consultation with the Attorney General.

(c) A violation of this section is an infraction punishable under the following schedule of mandatory fines:

First offense	\$100.00 fine;
Second offense	\$200.00 fine;
Third offense	\$300.00 fine.

Sec 2. 22.0807 is amended to read:

"22.0807 Uniform traffic ticket and complaint-summons.

(a) In the event of any violation of a provision of this title resulting in a misdemeanor or an infraction, proceedings may be instituted by the serving of a summons upon the violator.

(b) The summons shall be signed by a police officer of American Samoa and shall be substantially in the form known as the "Uniform Traffic Ticket and Complaint-Summons".


(c) When enforcing A.S.C.A. 22.0321(b) the summons shall be signed by police officers of American Samoa or authorized employees from the Office of Protection and Advocacy and shall be substantially in the form known as the "Uniform Traffic Ticket and Complaint-Summons".

(e)(d) No code section need be specified in the summons in any case in which the charged violation is specifically designated through the use of indicated boxes provided on the uniform ticket and complaint.


(d)(e) The summons may contain other information pertinent to the charged offense and such forms for appearance, plea and waiver as are necessary under 22.0815 et seq."

Sec 3. Effective date.


In accordance with Article II, Section 19 of the Revised Constitution of American Samoa, this bill shall become effective 60 days after the end of the session at which it has been passed.
