AN ACT APPROPRIATING THE SUM OF \$75,000 FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790, TO PAY IN FULL THE SETTLEMENT AGREEMENT ENTERED INTO AS A RESOLUTION OF LITIGATION ENTITLED EDWARD P. CRICHTON BY WINNIE CHANEL, ASG, DOE, ET AL, IN HIGH COURT CIVIL ACTION NO. 023-2002.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

**Section 1. Appropriation of revenue.**

There is appropriated the sum of \$75,000 from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790, for the purpose of full payment of the Settlement Agreement entered into as a resolution of litigation entitled Edward P. Crichton by Winnie Chanel, ASG, DOE, et al, in High Court Civil Action No. 023-2002.

**Sec 2. Source of funding.**

Funds in the amount of \$75,000.00 shall be payable from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790, and any funds remaining unexpended and unobligated for Fiscal Year 2004.




