AN ACT AMENDING THE FORMER GOVENORS' MONETARY ALLOWANCE TO
REFLECT THE CURRENT SALARY OF THE GOVERNOR IN OFFICE; AMENDING
SECTION 4.0110 A.S.C.A.

Preamble:

WHEREAS, Article IV of the Revised Constitution of American Samoa outlines the duties and responsibilities of the elected Governor and Lieutenant Governor. These duties and responsibilities require extensive measures of ensuring that proper actions and services are effectively provided to the people of the territory;

WHEREAS, since the outbreak of the pandemic, additional responsibilities and priorities of the government and leaders have shifted. These effects have increased the work load of our leaders in assessing and administering proper measures to safeguard our people; and

WHEREAS, as the primary leaders of our government, the governor and lieutenant governor serve to ensure that the greater good of the people are in place for the quality of life and service ; and

WHEREAS, the health and welfare of our people continues to be a priority of the government and the duties and responsibilities will continue to increase with the social and economic challenges of inflation and various diseases that reach our shores; and

WHEREAS, the current law mandates that each former governor is entitled to a monetary allowance of 60% based on their salary when in office. However, with the fluctuating cost of living it is fitting for this allowance to reflect the current salary of the Governor; and

~~WHEREAS, it is proposed that these amendments are to be effective in the next administration in 2026.~~

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. **Section 4.0110** is amended to read:

“4.0110 Compensation and perquisites—Allowances for former Governor and surviving spouses—“Former Governor” defined.

(a) The Governor is entitled to an annual salary of \$120,000 and other perquisites provided by law including but not limited to: the rent-free use of Government House (the Governor's official residence in Fagatogo); the free use of vehicles for executive, ceremonial duties and family use; and a reasonable food, beverage and entertainment budget for the official residence specified by line item in the Governor's annual fiscal budget.

(b) The Lieutenant Governor is entitled to an annual salary of \$100,000 a year and other perquisites as provided by law including rent-free government quarters, and free use of a vehicle for executive, ceremonial duties and family use.

(c) Each former Governor shall be entitled, for the remainder of his life, to receive from the American Samoa Government a monetary allowance at the rate per annum of ~~60% of his highest salary during his last year in office~~ the current governor's annual salary, payable monthly by the treasurer of American Samoa Government. However, such allowance is not payable for any period during which such former Governor holds an appointive or elective office or position in or under the American Samoa Government or the Federal Government to which is attached a rate of pay other than a nominal rate.

(d) The surviving spouse of each former Governor shall be entitled to receive from the American Samoa Government a monetary allowance at the rate per annum of 30% of the former Governor's highest salary during his last year in office, payable monthly by the Treasurer of the American Samoa Government. The monetary allowance of such surviving spouse;

- (1) commences on the day after the former Governor dies;
- (2) terminates on the last day of the month before such widow;
- (A) dies; or
- (B) remarries; and

(3) is not payable for any period during which such widow holds an appointive or elective office or position in or under the American Samoa Government or the Federal Government to which is attached a rate of pay other than a nominal rate.

(e) As used in this section, the term “former Governor” means a person:

(1) who, on or after January 1, 1978, shall have held the office of the Governor of the Territory of American Samoa for a full term of at least 4 years;

(2) whose service in such office shall have terminated other than by removal pursuant to A.S.C.A., 4.0109 of this chapter; and

(3) who does not then currently hold such office.


(f) Funds shall be made available from the Office of the Governor's budget.”

(a) O le Kovana e agavaa i se totogi faaletausaga e \$120,000 ma isi penefiti ua aiaia e le tulafono e aofia ae le faatapulaaina ai le faaaogaina saoloto o le Maota o le Malo (o le maota aloaia faalemalu o le Kovana i Fagatogo); faaaoga saoloto o taavale mo tiute faamalosi tulafono, sauniga faapitoa, ma faaaogaina e lona aiga; ma se paketi o meataumafa e talafeagai ai, meainu ma faafiafiaga mo le maota o le malo ua faamaoti i le faasoaga o tupesaaalu i le paketi faaletausaga a le Kovana.

(e) O le Kovana Lutena e agavaa i se totogi faaletausaga o le \$100,000 i le tausaga ma isi penefiti e pei ona aiaia e le tulafono e aofia ai fale o le malo e faaaoga saoloto, ma le faaaogaina saoloto o se taavale mo tiute faalemalu ma sauniga faapitoa, ma le aiga.

(i) O e uma na umia le tofi Kovana o le a agavaa, mo le taimi o loo totoe o lona soifua, e maua mai le Malo o Amerika Samoa se alauni tupe i le fua i tausaga taitasi o le 60% o ~~lona totogi aupito maualuga faaletausaga ao i ai o ia i le tausaga mulimuli o le tofi le totogi lea ua iai nei le Kovana i le tausaga~~, e totogi atu i masina taitasi e le Teutupe o le Malo o Amerika Samoa. (3) o sē e le o toe umia i le taimi nei lea tofi.


