AN ACT EXTENDING THE TEMPORARY ESTABLISHMENT OF THE “FAMILY, DRUG, AND ALCOHOL COURT” PILOT PROJECT FOR AN ADDITIONAL TWO YEAR PERIOD, AMENDING SECTION 3.0505 A.S.C.A.; AND PROVIDING FOR AN EARLY EFFECTIVE DATE.

Preamble:

Under the original language of this Act, it was to expire on October 1, 2002. To timely extend this Act for an additional two year period, this act shall be effective immediately upon passage by the Legislature and approval by the Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

**Section 1. 3.0505 is amended to read:**


**3.0505      Sunset provision.**




**Sec 2.      Effective date.**




